While approaching the downwind into FSD, we were notified by the Control Tower that they would be closing prior to touchdown at 0500z. Jepp FDPro says that Tower/Ground operations end at 0600z. If the correct time was published, I could have requested an alternate airport either before departing ZZZ or during cruise to our destination. Since the incorrect time was published and I wasn't made aware until approaching the downwind, I did not have the required alternate airport. NOTAMS not published w/regard to the correct local ATC operating times. Publish NOTAMS.

Air carrier pilot reported the ATC hours of operation at FSD airport are published incorrectly and operations end an hour before the published times.
